

Vantage West Local Business Video Giveaway Official Rules:

NO PURCHASE NECESSARY TO ENTER OR WIN. MEMBERSHIP NOT REQUIRED. LIMIT ONE PRIZE PER PERSON BUSINESS.

1. **How to Enter.** During the Promotion Period (March 12, 2018 – April 9, 2018) Arizona businesses can enter the contest by completing the entry form available at vantagewest.org/spotlight.

Limit (1) entry per business. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor (aka "Vantage West Credit Union."). You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

The drawing is open to legal residents of the United States and the State of Arizona as of March 12, 2018. If the selected winner is ineligible or cannot be contacted within two (2) days from the time selected an alternate finalist will be selected.

From the Ten (10) selected finalists, three (3) winners will be announced April 24, 2018 at 5:30pm at Roadhouse Cinemas at 4811 E Grant Road, Tucson AZ 85712. **Winners must be present to win.** If winner is not present, the prize will be forfeited and an alternate winner will be selected at the event. Vantage West Credit Union shall have no liability for a winner's failure to be present and claim prize.
