

Official Rules:

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP NOT REQUIRED. LIMIT ONE PRIZE PER PERSON

1. How to Enter.

During the Promotional Period (July 22 – October 1, 2018) you can enter the drawing by recording a video message inside one of our pop-up booths around town (at designated dates and locations announced at www.capitaloffense.org minimum 3 days in advance each time). Participants MUST sign a photography release to be eligible.

Limit (1) one entry per person, regardless of the method of entry. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor (aka “Vantage West Credit Union.”) You may not enter more times than indicated by using multiple identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

2. Eligibility.

The promotion is open to legal residents of the United States and the State of Arizona as of July 23, 2018. Residents of New York, Florida, Rhode Island and Puerto Rico and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. Persons in any of the following categories are NOT eligible to participate or win the prize: (a) employees, board members, supervisory committee members, or other volunteers of Vantage West Credit Union; (b) individuals engaged or employed by a company that is engaged in the development, production or distribution of materials; and (c) persons who are immediate family members (defined as mother, father, sister, brother, daughter, son or spouse) of any person in any of the preceding categories and individuals living with them in the same household. Subject to all applicable federal, state, and local laws and regulations. All eligible entries will be included.

3. Drawing and Procedure.

The drawing shall be referred to herein as the “Capital Offense Drawing.”

A total of six winners will be selected by random drawing on October 5, 2018. The drawing will be conducted by Vantage West Credit Union personnel or a third party designated at Vantage West Credit Union’s sole discretion. If a winner cannot be reached at the contact information provided, or if the prize is unclaimed, the prize will be forfeited. Winners will be notified the day of the drawing via the phone number or email address provided at contest entry. Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security

settings or for winners' provision of or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within two (2) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited. The receipt by winner of the prize offered in this Drawing is conditioned upon compliance with any and all federal and state laws and regulations.

ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CAPITAL OFFENSE DRAWING AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

4. Prize.

Odds of winning depend on the number of eligible entries received as of the deadline for the drawing. Prizes may not be transferred or assigned. No prize substitutions will be made. All applicable federal, state and local taxes are the winner's responsibility. The following prizes will be awarded.

- (1) One \$500 cash grand prize
- (2) Five \$100 cash prizes

5. General Conditions of Participation

By participating in the Capital Offense drawing, participant agrees to abide by and be bound by these official rules and the decisions of Vantage West Credit Union, which are final. By participating, winner releases and agrees to hold harmless the Sponsor, including any parents, subsidiaries and all of its respective directors, officers, employees, representatives and agents (the "Released Parties"), from and against any and all liability for any loss, property damage or damage to persons, including, without limitation, death and injury, due in whole or in part, directly or indirectly, arising out of participation in the drawing or use or misuse of any prize. By entering the Capital Offense Drawing you agree to receive email from Vantage West Credit Union. You can opt-out of receiving this communication at any time by clicking the unsubscribe link.

6. **Limitations of Liability.** The Sponsor is not responsible for computer, network, printing, typographical, human or other errors, problems or malfunctions relating to or in connection with the Capital Offense Drawing, including, without limitation, errors, problems or malfunctions which may occur in connection with the administration of the Capital Offense Drawing, the announcement of the winner, the processing of entries or in any Capital Offense Drawing-related materials; for stolen, lost, late, misdirected, undelivered, damaged, inaccurate, delayed,

incomplete, illegible, or postage-due mail or entries; or for transactions that are lost, misdirected, or fail to enter into the processing system for any reason; or are processed, reported, or transmitted late or incorrectly; or are lost for any reason, including computer, telephonic, paper-transfer, or human error, or electronic, computer, or telephonic malfunction, damage, error, omission, interruption, defect, delay in operation or transmission, or any combination thereof. If, for any reason, the Capital Offense Drawing is not capable of running as planned, or infection for computer viruses, bugs, or tampering, unauthorized intervention, fraud, actions of entrants, technical failures, or any other causes corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Capital Offense Drawing, the Sponsor reserves the right to disqualify any entry or entrant and/or to cancel, terminate, modify, or suspend the Capital Offense Drawing and at its sole discretion to disqualify any entry or entrant and/or to cancel, terminate, modify, or suspend the Capital Offense Drawing and to award the prize to the selected winner among all eligible non-suspect entries validly received prior to the action requiring such modification.

7. **Dispute.** Except where prohibited, participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Capital Offense Drawing or any prize awarded shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Capital Offense Drawing, but in no event attorneys' fees; and (3) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
