

2019 Dusk Music Festival Ticket Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP NOT REQUIRED. LIMIT ONE PRIZE PER PERSON.

1. How to Participate.

During the Promotional Period (10/4/19-10/18/19) you can enter the drawing by completing a form at www.VantageWest.org/DUSK.

Limit (1) one entry per person. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Vantage West Credit Union (the "Sponsor"). You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within four (4) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner will be selected. All applicable federal, state and local taxes are the winner's responsibility. The entry and winning process is deemed as a game of change. The winner will be chosen by random drawing. If the selected winner does not respond within four (4) days after being notified, they forfeit their prize and another winner will be selected. Tickets will be sent to the winner electronically by e-mail and as a PDF file. Winners will be required to bring a printed version of the PDF or have the PDF available on their mobile device to the festival box office.
