
Vantage West Credit Union Guidelines for Petitioning at Vantage West Locations

1. Petitioners must be current Vantage West Members.
2. Activities are allowed only between February 21 and March 24, 2023, during normal business hours.
3. Petitioners must notify branch management prior to setting up or beginning to collect signatures.
4. A small table, no larger than a standard card table, may be used and must be supplied by the petitioner.
5. Supplies such as paper, pens, etc. will not be provided by the Credit Union or its employees.
6. Signature gathering activities may not impede Member or employee access or traffic flow.
7. Petitioners may not approach another Member without first getting that Member's permission to approach.
8. Petitioners may not infringe upon the privacy of other Members or conduct their activities in locations that may violate the confidentiality of Member transactions or other business.
9. No signage or other materials may be affixed to walls, desks, doors, or other internal or external Credit Union owned surfaces.
10. Devices that emit sound or flashing lights are not permitted.
11. Petitioners may not state or imply that they have been endorsed by the Credit Union.
12. While on Credit Union property petitioners may not speak to the media, make disparaging remarks about the Credit Union, its employees or officials, or record or transmit audio or video.
13. Logos or other intellectual property owned by Vantage West Credit Union may not be used on any petition-related materials.
14. Conversations related to petitioning must be kept to normal volume levels.
15. Petitioners may not solicit signatures from Credit Union employees during the employee's work time.
16. Any petitioner who becomes disruptive, confrontational, vulgar, or displays otherwise inappropriate behavior will be required to cease petitioning activities immediately.
17. Trash or any other petition-related materials must be disposed of by the petitioner.
