

## **DUSK Music Festival Ticket Giveaway Official Rules:**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. PROMOTION OPEN TO VANTAGE WEST CREDIT UNION MEMBERS ONLY. LIMIT ONE PRIZE (TWO TICKETS) PER PRIMARY ACCOUNT HOLDER.

### **1. How to Participate.**

During the Promotional Period October 11, 2023, from 8:00 a.m. to October 18, 2023, at 11:59 p.m. MST you can enter the drawing by completing an entry form with your name, address, email address and phone number at [www.VantageWest.org/DUSK](http://www.VantageWest.org/DUSK).

Limit (1) one entry per primary account holder. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Vantage West Credit Union (the "Sponsor"). You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

### **2. Eligibility.**

The promotion is open to legal residents of the United States as of October 11, 2023. Residents of New York, Florida, Rhode Island and Puerto Rico and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of or otherwise non-functioning contact information. If a selected winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited.
