

2019 Vantage West Local Business Video Giveaway Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP NOT REQUIRED.

1. How to Participate:

During the Promotional Period (May 6, 2019 – May 31, 2019) Arizona businesses can enter the contest by completing the entry form available at VantageWest.org/Spotlight. The following question will be listed on the entry form: Why should your business be featured in Thrive Arizona?

Limit (1) entry per business. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor (aka "Vantage West Credit Union."). You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

2. Eligibility:

The Giveaway is open to legal residents of the United States as of May 6, 2019. Residents of New York, Florida, Rhode Island, and Puerto Rico and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. The winner (1) will be contacted via the email address and/or phone number that was provided on the entry form. Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of or otherwise non-functioning contact information. The receipt by winner of the prize offered in this contest is conditioned upon compliance with any and all federal and state laws and regulations. If the selected winner is ineligible or cannot be contacted within two (2) days from the time selected an alternate finalist will be selected.
