



Tatum and Shea Giveaway Official Rules

Sponsored by Vantage West Credit Union (“Sponsor”)

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ONLY OPEN TO VANTAGE WEST MEMBERS. LIMIT ONE WINNER EACH MONTH DURING THE PROMOTIONAL PERIOD FOR A TOTAL OF THREE (3) WINNERS.

1. How to Participate.

The Promotional Period begins on (April 1, 2026, from 12:00 a.m. MST to June 30, 2026, 11:59 p.m. MST). Mountain Standard Time shall control for all purposes of the promotion. Sponsor’s computer shall be the official clock of the promotion. During the Promotional Period, you can enter the Promotion via one (1) of two (2) ways:

- i. Open a Vantage West Credit Union Essential Checking Account at the Tatum and Shea branch (10855 N. Tatum Blvd, Suite 180, Phoenix, AZ 85028) during the promotional period. The account must meet all minimum opening requirements and remain open for six (6) months. If the account is closed within six (6) months of the opening date, you may be responsible for reimbursement of any bonus awarded.
- ii. Mail a postage prepaid, hand printed 3.5 x 5-inch card containing the name, e-mail address and phone number of the participant to the following address: Vantage West Credit Union, PO BOX 15115 Tucson AZ 85708. Only entries received during the Promotional Period will be accepted. All entries must be received by June 30, 2026, for entry. No computer generated/photocopy entries or entries received via facsimile will be permitted.

Limit one (1) entry per person, regardless of method of entry. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Vantage West Credit Union (the “Sponsor”). You may not enter more than indicated by using multiple email addresses, identities, accounts, or devices to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

2. Eligibility.

The promotion is open to legal residents of the United States as of April 1, 2026. Residents of New York, Florida, Rhode Island and Puerto Rico and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. Persons in any of the following categories are NOT eligible to participate or win the prize: (a) employees, volunteers or Board members of Vantage West Credit Union; (b) individuals engaged or employed by a company that is engaged in the development, production or distribution of materials; and (c) persons who are immediate family members (defined as mother, father, sister, brother, daughter, son or spouse) of any person in any of the preceding categories and individuals living with them in the same household. Subject to all applicable federal, state, and local laws and regulations. All eligible entries will be included.

3. Drawing and Procedure.

The drawing shall be referred to herein as “Tatum and Shea Giveaway.” One (1) winner will be selected by random drawing within five (5) business days of the end of each month during the entry period, for a total of three (3) winners. The drawing will be conducted by Vantage West Credit Union personnel. Winners will be either notified via email, to the email address on file or the phone number on file with your account within two (2) business days following the winner selection. Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to

winner's spam, junk e-mail or other security settings or for winners' provision of or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited. The receipt by the winner of the prize offered in this Drawing is conditioned upon compliance with any and all federal and state laws and regulations. All decisions of Vantage West Credit Union are final.

Winners will receive a one-time cash award of \$1,000 which will be deposited into the winner's regular share savings account within five (5) days of completing all necessary requirements. Odds of winning depend on the number of eligible entries received as of the deadline for the drawing. Prize may not be transferred or assigned. No prize substitutions will be made. All applicable federal, state, and local taxes are the winner's responsibility. The entry and winning process is deemed as a game of chance. The winners will be chosen by random drawing. The winners will be notified up to two (2) days after the selection is made. If the selected winner does not respond within seven (7) days after being notified, they forfeit their prize. Winners must have an open Vantage West account to receive prize. Upon prize acceptance, the winners will receive a one-time cash award of \$1,000 which will be deposited into the winner's regular share savings account, at Sponsor's sole discretion subject to compliance with these Official Rules, including, but not limited to the return of any requested forms and information from the potential prize winner.

In the case of unavailability of any prize, Sponsor reserves the right to substitute a prize of equal or greater value.
