

Vantage West Gift Card Grab Giveaway Official Rules:

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP NOT REQUIRED.

1. How to Participate.

During the Promotional Period (July 20, 2026, from 8:00 a.m. to July 23, 2026, at 11:59 p.m. MST), you can enter the drawing by filling in the required fields and submit the entry form located at <https://share.hsforms.com/1IIUCOyMwRySNPo59df7n9wqvctl>. Limit one (1) entry per person. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Vantage West Credit Union (the "Sponsor"). You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Vantage West Credit Union.

2. Eligibility.

The promotion is open to legal residents of the United States as of July 20, 2026. Residents of New York, Florida, Rhode Island, Puerto Rico, and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. Vantage West Credit Union shall have no liability for a winner's failure to receive notices due to the winner's spam, junk e-mail, or other security settings or for the winner's provision of or otherwise non-functioning contact information. If a selected winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time the award notification was sent or fails to timely return a completed and executed declaration and releases as required, the prize may be forfeited, and an alternate winner will be selected.
